- The Complaint Redressal Committee regarding sexual harassment at school premises should be formed as per government resolution, woman and child department No.मकचौ-2013/ प्र.क्र.63/मकक, Dated 19.6.2014 and subsequent provisions in Act and Rules.
- Fee Structure of the school shall be displayed on Government's RTE portal.
- 15. School shall enter the Aadhar Number of the students on SARAL portal.
- The State Government reserves the rights to withdraw the above certificate at any time without giving 16. prior notice and without assigning any reason if any deviation of rules reported in future and the management falls to comply with the instructions of the State Government.
