As per the proposal, approval has been granted based on the conditions and terms specified below.

Terms & Conditions:

- The current school must ensure compliance with all the rules and regulations made under the Right to Free and Compulsory Education Act, 2009.
- The said school Management has complied with all the terms in Act 2009, And hence it is permitted to start the school from the academic session 2017-18 as below.
 - a) The school management should apply to the Education Officer of the district for Recognition within one month from the beginning of the academic session, as per the rules.
 - b) The management must start the school within 18 months from the date of approval after compliance of all the terms as per the government. Else, the permission will stand cancelled.
 - c) As per all the terms prescribed in the government decision dated 20th June 2012, obtaining the No - Objection Certificate (N.O.C) is first necessary. For



this, the school must first obtain recognition. After receiving recognition from the District Education Officer (Primary)/District Education Officer (Secondary)/Education Inspector, Greater Mumbai, as per Section 10 of the current government decision, the institution should apply to the government for the No-Objection Certificate along with the recognition letter from the institution affiliated with the Board. If the current application is scrutinized and if the institution fulfills the prescribed norms, conditions, and criteria, then the government will issue the No-Objection Certificate (N.O.C) for the inclusion of the institution in the Board.

- 3 The newly established school, granted permission must adhere to i) the procedures of orders issued by the government from time to time and ii) comply with all provisions of the Maharashtra Self-supporting School
 - (Establishment and Regulation) Act, 2012 (Year 2013, No. 01).
- 4 Ensure the authenticity of compliance with the provisions of the 2009 Act by the relevant competent authorities, and proceed with further action regarding granting initial approval thereafter.
- 5. Any changes made in the medium of application for school permission, location of the school, etc., will not be considered in the future. The permission for the school given by the government for the specific location. If the school is started in any other location except for that, the permission given by the government will automatically be considered revoked.
- 6. U-DISE Data: When filling in the information in the U-DISE (Unified District Information System for Education) about the new schools/granted permissions by this government decision, district-level information must be provided regarding the self-help element for obtaining permission. For further action on this matter, the State Project Director, Maharashtra State Primary Education Council, Mumbai, is declared as the nodal officer
- Accordingly, the institution should follow the established rules and principles of the government for the recruitment of teachers and other staff in the self-financing schools that have been granted permission.

The government's existing rules and regulations shall be strictly enforced, and compliance with such rules will be mandatory.
